To: Lenders Participating In the Health Education Assistance Loan (HEAL) Program

Subject: Completing HEAL Borrower Status Form HRS A- 508: Additional Skip Trace Assistance - HEAL Lenders 87-3

Some lenders have been experiencing difficulty In obtaining completed HEAL Borrower Status Forms, HRSA-508, from borrowers in deferment status. Because of the borrowers' failure to furnish this information, the loans are placed in a delinquent status and say ultimately result in a default claim.

We are concerned about the number of claims being submitted to us on this basis. Because of this concern, we are again requesting your cooperation in researching these cases and employing every available means for obtaining this information. We have agreed to accept written documentation on official letterhead for these borrowers In lieu of the Borrower Status Form.

We have also attempted to obtain other sources besides the school for locating the place of residency training for a borrower. You my contact the following organization and request a current listing of borrowers in medical residency programs across the country.

The American Dental Association (ADA) has volunteered to assist HEAL lenders in locating dental school graduates who are delinquent in repaying HEAL loans. The ADA has no information concerning non-graduates.

Prior to requesting ADA assistance you should utilize all skip-tracing techniques at your disposal. Should you need to request the ADA assistance, you should call 202-898-2400, the ADA Washington Office, and say that you are requesting assistance in locating a HEAL borrower. You should provide the following borrower information to the ADA receptionist:

- Complete name
- Last known address
- Social security account number
- Dental school and date of graduation

You should also provide your institution name, telephone number and contact person. If the ADA is successful they will provide an address to you by telephone. If they are unsuccessful they will not contact you.
